WHEREAS, be it known that Ormoc City is one of the most progressive agricultural region in the province, considering that thousands of its vast area is in dire need of irrigation system;

WHEREAS, the Irrigation program of the vast fertile land at Ormoc City is the concern of the City Officials and the farmers of the City of Ormoc and that the accomplishment of said irrigation projects would solve the food shortage now locally prevailing; and

WHEREAS, the Municipal Board of Ormoc City knowing the importance of having an irrigation system in the City of Ormoc desires to respectfully request the Director, Bureau of Public Works, Manila that Ormoc City be included in the program for the construction of irrigation system;

NOW THEREFORE, the Board, on motion of Councilor Usualdo F. Laguitan seconded by Councilor Guillermo T. Parrilla;

BE IT RESOLVED, as is hereby resolved, to respectfully request the Director, Bureau of Public Works, Manila that Ormoc City be included in the program for the construction of irrigation system;

Domingo Veloso, Speaker Pro-tempore, House of Representatives, Manila; City Mayor, Ormoc City; City Treasurer, Ormoc City; City Auditor, Ormoc City and the District Irrigation Engineer, Eastern Visayas Irrigation District, Palo, Leyte.


