RESOLUTION NO. 136

WHEREAS, the Municipal Board of Ormoc City passed resolution No. 136, c.s. correcting the impression of the Office of the Div. Supt. of Schools, Tacloban, Leyte to the effect that the positions of Miss Pascualita Gonzales, Steno-typist and Mr. Romulo Rosal, Office Clerk, Office of the Supervisor, Ormoc District II, Ormoc City are not provided in the annual budget for the year 1952-1953 when as a matter of fact said positions are so provided in the budget as approved by the Municipal Board;

WHEREAS, the Hon. City Mayor, vetoed said resolution No. 136 for the reasons stated in the veto;

WHEREAS, Councilor Guillermo T. Parrilla manifested that the veto of the Hon. City Mayor on Resolution No. 136 is not well taken because these positions occupied by Miss Gonzales and Mr. Rosal are not newly created positions but are old positions provided for in the previous budget, particularly the budget for 1951-1952, otherwise known as Resolution No. 143, Ordinance No. 11;

NOW THEREFORE, the Board, on motion of Councilor Guillermo T. Parrilla, seconded by Councilor Alvaro I. Gutierrez;

BE IT RESOLVED, as is hereby resolved to over-ride the veto of the Hon. City Mayor on Resolution No. 136, c.s.;

RESOLVED FINALLY, to furnish copy of this resolution each to the Hon. Executive Secretary, Malacañan Palace, Manila; Hon. City Mayor, Ormoc City; City Treasurer, Ormoc City; City Auditor, Ormoc City and the Div. Supt. of Schools, Tacloban, Leyte.
