RESOLUTION NO. 140

WHEREAS, on the suggestion of Councilor Guillermo T. Parrilla to approve the claim of Engineer Reynes in the amount of ₱4,241.15 for the extra concrete piers of the City Hall Building of Ormoc City; the same to be carried as outstanding obligation of the City on the next fiscal budget, 1953-54;

VETO OR RESOLUTION NO. 140, CURRENT SERIES  
OF THE HONORABLE MUNICIPAL BOARD OF  
ORMOC CITY PURSUANT TO REPUB-  
LIC ACT NO. 179

By virtue of the powers vested in me by Art. 3, Sec. 14, of Republic Act No. 179, otherwise known as the Charter of Ormoc City, the undersigned hereby vetoes Res. No. 140, series of 1952, of the Honorable Municipal Board, this City, with the grounds hereunder enumerated:

- (a.- Resolution No. 140, current series which resolved to approve the claim of Engr. Reynes for extra payment for the construction of the concrete piers of the City Hall Building is too premature;
- (b.- Whereas in connection with this claim, the Hon. Municipal Board, this City, approved Res. No. 124, c. s. dated August 16, 1952, requesting City Engr. Felix Codilla of Naga City to come over to Ormoc City to help the Municipal Board determine the truth and justice of said claim as he was the incumbent City Engineer at the time the City Hall of Ormoc City was constructed;
- (c.- Inasmuch as Engr. Codilla has not yet come over to explain to the Municipal Board in open session on the justice of the claim of construction Engineer Francisco T. Reynes of Cebu City, it would be exposing the integrity and sound judgment of the Municipal Board concerned before the eyes of the public, with the consequent embarrassment of the members of the Hon. Body before the eyes of the people if Resolution No. 140 hereby vetoed, be approved without further ado;
- (d.- It has been the consistent stand of the Municipal Board on the subjectmatter at issue that since it involves a large sum of money which would affect the Finance of the City this coming fiscal year, closest scrutiny should be made by the Municipal Board with reference to a detailed report and final recommendation that may be made by Engr. Codilla. By approving the payment, knowing that Engr. Codilla opposes the payment thereof, would be unreasonable without giving due weight to whatever recommendation said Engr. Codilla may have on the matter.

In view of the foregoing, the undersigned respectfully submits this veto on Res. No. 140, c. s. requesting that before this resolution be approved, Engr. Codilla be given a chance to express his views.
