RESOLUTION NO. 141

WHEREAS, the Municipal Board of Ormoc City passed resolution No. 138, c.s., effecting the installation of telephones to every residence of City Councilors, the Hon. City Mayor, the Vice-Mayor and also the Office of the Secretary to the Municipal Board; the installation fees and the monthly fees to be taken from the items of the Office of the Municipal Board intended for the traveling expenses of City Councilors' travel to barrios;

WHEREAS, the City Treasurer, Ormoc City, in a letter dated September 16, 1952 addressed to the Municipal Board thru the Hon. City Mayor, quoting therein a portion of Section 825(c) of the Manual of Instructions to Treasurers, informed the Hon. Body that with the exception of the Hon. City Mayor, the other city officials mentioned in resolution No. 138, c.s. are not entitled to government telephone service at their residences;

WHEREAS, the City Treasurer further informed the Hon. Body that telephone services to the residences of the officials concerned cannot be considered in order unless prior approval by the proper Department Head is secured;

NOW THEREFORE, the Board, on motion of Councilor Jorge S. Tan, seconded by Councilor Guillermo T. Parrilla;

BE IT RESOLVED, as is hereby resolved to respectfully request the Hon. Executive Secretary, Malacañan Palace, Manila to approved Resolution No. 138, c.s. of the Municipal Board, Ormoc City as an exception to Section 825(c) of the Manual of Instructions to Treasurers;

FINALLY RESOLVED, to furnish copy of this resolution each to the Hon. Executive Secretary, Malacañan Palace, Manila; the Hon. City Mayor, Ormoc City; City Treasurer, Ormoc City; City Auditor, Ormoc City, and the Manager, Veloso-Leuterio Telephone Company, Ormoc City.
