RESOLUTION NO. 144

WHEREAS, be it known that the Municipal Board, Ormoc City, passed resolution numbered 124, c.s. requesting the Hon. Director of Public Works, Manila to order Engineer Felix C. Codilla, City Engr. of Naga City to come to Ormoc City to explain matters regarding the claim of Engr. F. T. Rynes for an extra payment in the amount of P4,241.15 for the construction of the concrete piers of the City Hall Building;
