Sir:

Request that an appropriation be created by that
Hon. Body for the payment of the salary difference of
Patrolman Patricio Bagobe in the amount of Twenty-Five
Pesos (P25.00) covering the period from July 1 to November
30, 1949.

Attached hereto is a true copy of the appointment
of Patrolman Bagobe duly approved by the Commissioner of
Civil Service of the amount of Fifty-Five Pesos (P55.00)
to Sixty Pesos (P60.00) per month.

Patrolman Patricio Bagobe should have been entitled
to a salary of Sixty Pesos (P60.00) beginning from the
month of July to November 30, 1949, but he was only paid
the amount of Fifty-Five Pesos (P55.00) due to the delay
in the approval of his appointment.


