RESOLUTION NO. 146

WHEREAS, on suggestion of Councilor Victorino C. Teleron to repeal the resolution, series 1951, appropriating the amount of P600.00 as revolving fund for the purchase of striptomycin in the City Health Department, Ormoc City; said amount having been deposited in the Office of the City Treasurer with the profits;

WHEREAS, Councilor Teleron further suggested to the Hon. 
