WHEREAS, be it further known that the fresh, dried and salted fish vendors are now occupying both sides of real Street;

WHEREAS, Councilor Alvaro I. Gutierrez strongly suggested to the Hon. Body to appropriate the amount of P400.00 for the construction of a temporary shade in the fresh fish section of the public market the same to be taken from the unappropriated balance otherwise not appropriated;

RESOLVED FURTHER, that the amount of ₱2,932.98 as above appropriated be taken from the unappropriated balance not otherwise appropriated;


