RESOLUTION NO. 153

WHEREAS, be it known that on the evening of October 4, 1952, a big and disastrous conflagration struck the City of Ormoc damaging properties amounting to more or less One Million Pesos (P1,000,000.00);

WHEREAS, as an immediate consequence of this unforeseen calamity, the City Government of Ormoc inevitably expects a rugged fluctuation of its revenues;

WHEREAS, because of the expected decline in the revenues of the City of Ormoc, the Municipal Board deems it a dire necessity to ask aid from the Department of Education, Manila in order to run smoothly the operation and maintenance of both the Ormoc Elementary and High School classes;

WHEREAS, it is apparently impossible - taking into account the expected falling finances of the City Government of Ormoc - to adequately surmount this huge expenses for both the Elementary and High School classes;

NOW THEREFORE, the Board, on motion of Councilor Usualdo F. Laguitan, seconded by Councilor Guillermo T. Parrilla;

BE IT RESOLVED, as is hereby resolved, to respectfully request the Hon. Secretary, Department of Education, Manila, to give aid to Ormoc City in the amount of P25,000.00 in order to continue the maintenance and operation of both the Elementary and High School classes;

RESOLVED FURTHER, that the aid be given at the earliest practicable date so that Ormoc City can continue to maintain and operate smoothly, both the Elementary and High School classes;

FINALLY RESOLVED, to furnish copy of this resolution each to the Hon. Secretary, Department of Education, Manila, the Hon. City Mayor, Ormoc City; City Treasurer, Ormoc City and the City Auditor, Ormoc City.
