RESOLUTION NO. 156

WHEREAS, the Municipal Board of Ormoc City passed resolution No. 155 c.s. appropriating the sum of P5,000.00 the same to be taken from the Maintenance of City Streets (J-27-6) for the construction of artesian wells at Linao and Cogon Combado;

WHEREAS, the City Engineer, Ormoc City on his 1st indorsement dated October 15, 1952 strongly objected to the reversion of said funds from the Maintenance of City Streets in view of the fact that the same is contrary to the existing rule that the streets and bridge fund is a special fund maintained in the city treasury;

WHEREAS, the City Engineer further informed the Hon. Body that said reversion of fund to the construction of artesian wells would affect adversely the repairs and improvements of city roads and bridges, said fund having had limited income;

NOW THEREFORE, the Board, on motion of Councilor Alvaro I. Gutierrez, seconded by Councilor Iñaki Larrazabal;

BE IT RESOLVED, as is hereby resolved to amend Resolution No. 155 c.s.;

RESOLVED FURTHER, to appropriate the sum of THREE THOUSAND PESOS (P3,000.00) for the construction of artesian well at barrio Linao, Ormoc City;

RESOLVED FURTHERMORE, that the sum of P3,000.00 as above appropriated be taken from the unappropriated balance not otherwise appropriated;

RESOLVED FINALLY, to furnish copy of this resolution each to the City Mayor, Ormoc City; City Treasurer, Ormoc City; City Auditor, Ormoc City and the City Engineer, Ormoc City.
