RESOLUTION NO. 157

WHEREAS, be it known that the City Government of Ormoc has constructed a fish pond at barrio Caguhagin, Ormoc City for the propagation of goramy fish;

WHEREAS, Mr. Protasio Escorro, City Agronomist of Ormoc City, being present during the deliberation of the Hon. Body informed the Hon. Members of the Board that an amount of P10,000.00 is necessary for the improvement and enlargement of said fish pond and for the construction of an additional one that will occupy around one-half (1/2) hectare in view of the rapid progress of the propagation of the goramy fish;

WHEREAS, in view of the precarious financial condition of the City Government of Ormoc due to the recent disastrous conflagration that occurred on the evening of October 4, 1952, the Municipal Board of Ormoc City deems it a dire necessity to ask aid from the Bureau of Fisheries, Manila, for the improvement and enlargement of the fish pond of Ormoc City and for the construction of an additional one for the propagation of goramy fish;

NOW THEREFORE, the Board, on motion of Councilor Jorge S. Tan, seconded by Councilor Victorino C. Teleron;

BE IT RESOLVED, as is hereby resolved, to respectfully request the Hon. Director, Bureau of Fisheries, Manila, to give aid to Ormoc City in the amount of P10,000.00 for the improvement and enlargement of the fish pond and for the construction of an additional one for the propagation of goramy fish;

RESOLVED FINALLY, to furnish copy of this resolution each to the Hon. Director of Fisheries, Manila; Hon. Domingo Veloso, Speaker-Protempore, HR, Manila; the Hon. City Mayor, Ormoc City; City Treasurer, Ormoc City; City Auditor, Ormoc City and the City Agronomist, Ormoc City.
