RESOLUTION NO. 158

WHEREAS, the Municipal Board is the recipient of a copy of the telegram sent by Mr. Aguilar of the Bureau of Public Schools, Manila to the Div. Supt. of Schools, Tacloban, Leyte, requesting information whether one-half (1/2) of the salary of Mr. Pedro Gillamac, Central School Principal for Ormoc District II is paid from the general fund of Ormoc City;

WHEREAS, Councilor Victorino C. Teleron, Chairman of the Committee on Finance, informed the Hon. Body that the City Government of Ormoc is not in a position to defray the requested one-half (1/2) salary of Mr. Gillamac in view of the present precarious financial condition;

WHEREAS, it is the desire of the Municipal Board of Ormoc City to respectfully request the Director of Public Schools, Manila, that the status of Mr. Gillamac as a national employee be continued and that his salary be borne by the National Government;

NOW THEREFORE, the Board, on motion of Councilor Victorino C. Teleron, seconded by Councilor Usualdo F. Laguitan;

BE IT RESOLVED, as is hereby resolved, to respectfully request the Hon. Director of Public Schools, Manila that the status of Mr. Gillamac as a National employee be continued and that his salary be borne by the National Government in view of the fact that the City Government of Ormoc is not in a position to defray one-half (1/2) of the salary of Mr. Gillamac due to its precarious financial condition;

RESOLVED FINALLY, to furnish copy of this resolution each to the Hon. Director of Public Schools, Manila; City Mayor, Ormoc City; City Treasurer, Ormoc City and the City Auditor, Ormoc City; info. copy to Mr. Pedro Gillamac, Principal, Ormoc District II, Ormoc City.
