RESOLUTION NO. 152

WHEREAS, the City Engineer, Ormoc City, being present during the deliberation of the Municipal Board informed the Hon. Members that the present water system of Ormoc City cannot adequately supply enough water to meet the needs of the city residents;

WHEREAS, Councilor Alvaro I. Gutierrez further informed the Hon. Body that during the recent disastrous conflagration that occurred on October 4, 1952 the fire department personnel of Ormoc City were not able to extinguish the fire due to the very low pressure of water;

WHEREAS, the City Engineer strongly suggested to apply for a loan from the RFC, Manila in the amount of P250,000.00 to rehabilitate the present water system or to look for another source of water in order to increase the volume of water sufficient to meet the needs of the residents of the city proper and the fire department in case of emergency;

NOW THEREFORE, the Board, on motion of Councilor Alvaro I. Gutierrez; seconded by Councilor Iñaki Larrazabal;

BE IT RESOLVED, as is hereby resolved, to apply for a loan from the RFC, Manila, in the amount of P250,000.00 to rehabilitate the present water system of Ormoc City or to look for another source of water in order to increase the volume of water sufficient to meet the needs of the residents of the city proper and the fire department in case of emergency;

RESOLVED FINALLY, to furnish copy of this resolution each to the Rehabilitation Finance Corporation, Manila; the Hon. City Mayor, Ormoc City; City Treasurer, Ormoc City City Auditor, Ormoc City and the City Engineer, Ormoc City.
