RESOLUTION NO. 171

WHEREAS, Lt. Jesus R. Tan, Acting Chief of Police, Ormoc City in his letter dated October 17, 1952 requested the Honorable Body to appropriate the sum of THREE HUNDRED PESOS (P300.00) for the purchase of uniforms for prisoners;

WHEREAS, Councilor Usualdo F. Laguitan further requested the Hon. Body to appropriate the sum of SEVEN HUNDRED EIGHTY SIX PESOS (P786.00) for the purchase of shoes for the members of the Police Department;

NOW THEREFORE, the Board on motion of Councilor Usualdo F. Laguitan seconded by Councilor Guillermo T. Parrilla;

BE IT RESOLVED, as it is hereby resolved to appropriate the sum of ONE THOUSAND EIGHTY SIX (P1,086.00) PESOS; P786.00 for the purchase of shoes for the members of the Police Department and P300.00 for the purchase of uniforms for prisoners;

BE IT RESOLVED FURTHER, that the sum of P1,086.00 as above appropriated be taken from the unappropriated balance not otherwise appropriated;

RESOLVED FINALLY, to furnish copy of this resolution each to the City Mayor, Ormoc City; City Treasurer, Ormoc City; City Auditor and the City Chief of Police, Ormoc City.
