RESOLUTION NO.172

WHEREAS, Councilor Guillermo T. Parrilla brought to the attention of the Hon. Body the claim of Mr. Rafael Yrastorza of the portion of his Lot along Burgos and Bonifacio Sts. which was affected by the widening of city streets;

WHEREAS, Councilor Parrilla further informed the Hon. Members of the Board that the area affected in the widening of said streets is 43.76 sq.m. more or less as per 1st indorsement of the city engineer dated November 15, 1952;

WHEREAS, the Councilor strongly suggested to pay FIFTEEN PESOS (P15.00) per square meter inasmuch as the said area affected in the widening is within the commercial zone;

NOW THEREFORE, the Board, on motion of Councilor Guillermo T. Parrilla, seconded by Councilor Teotimo Ocubillo;

BE IT RESOLVED, as it is hereby resolved, to appropriate the sum of SIX HUNDRED FIFTY SIX (P656.40) PESOS & FORTY CVOS. to pay the portion of the lot of Mr. Rafael Yrastorza utilized by the city government in the widening of city streets with an area of 43.76 sq.m. at P15.00 per square meter;

RESOLVED FURTHER, that the sum of P656.40 as above appropriated be taken from the unappropriated balance not otherwise appropriated;

RESOLVED FINALLY, to furnish copy of this resolution each to the City Mayor, Ormoc City; City Treasurer, Ormoc City; City Auditor, Ormoc City; City Engineer and to Mr. Rafael Yrastorza, Ormoc City.
