## RESOLUCION O.

WHEREAS, Councilor will rm . Pavilla anifested before the Honorable Bod that Ornor City lacks public playgrounds facilities for the improve t of the health of the population;

WHEREAS, like my other charged cities in the Philippians, O moc City ought to have several public play-grounds there the people could recreate and improve their health:

Aposition to entray the expenses for the construction of the same in view of its precarious financial condition;

WER said Councilor expressed the view that the master at purpose may be raised by charging corn and rise miles of trace city a nominal inspection fee of five centers (PO.05) for every palay and/or corn milled and gas line stations, one-fourth (1/4) of a centavo for every liter of gasoline sold, the same to be made effective for a period of only three (3) months;

WHEREAS, he further expressed the view that those affected are civic minded and therefore, willing to cooperate in the promotion of the health of the Community;

NOW THEREFORE, the Board, on motion of Councilor Guillermo T. Parrilla, seconded by Councilor Teotimo Ocubillo;

BE IT RESOLVED, as is hereby resolved to charge corn and rice mills five centavos (PO.05) as nominal inspection fee for every cavan of play and/or corn milled and one-fourth centavo (1/4) for every liter of gasoline sold by Gasoline stations of Ormoc City, the same to be made effective from December 1, 1952 to February 28, 1953;

RESOLVED FURTHER, that the amount raised be appropriated for the construction of parks and grounds;

RESOLVED FINALLY, to furnish copy of this resolution each to the Hon. City Mayor, OrmocCity; City Treasurer, OrmocCity; City Auditor, Ormoc City and to all operators of Born and Rice Mills and Gasoline Stations, Ormoc City. CARRIED UNANIMOUSLY.
