RESOLUTION NO. 176

WHEREAS, be it known that sixty-seven (67) landowners and tenants of barrios San Jose, Balion and Sabang Bao of this City petitioned the Hon. Body requesting for an appropriation enough to establish an irrigation system utilizing the Bao River to irrigate the rice fields of said petitioners containing an area of more or less three thousand (3,000) hectares;

WHEREAS, the construction of said irrigation system would greatly increase the yearly produce of the rice fields affected, thus minimizing the rice shortage of the locality;

WHEREAS, Dr. Herminigildo I. Serafica, representing the petitioners of the three barrios aforementioned, requested the Hon. Body to take representation to Hon. Domingo Veloso, Speaker Protempore, House of the Representatives, Manila, to set aside thirty thousand pesos (P30,000.00) out of his Pork Barrel Fund for the construction of said irrigation system inasmuch as the city of Ormoc is not in a position to appropriate funds for the construction of the same;

WHEREAS, the Municipal Board, acting on the request of the landowners and tenants of the three barrios aforementioned, hereby respectfully convey to Hon. Domingo Veloso, Speaker Protempore, House of the Representatives, Manila, the request of the petitioners headed by Dr. H. I. Serafica, to set aside P30,000.00 out of his Pork Barrel Fund for the construction of irrigation system utilizing the Bao River to irrigate the rice fields of barrios San Jose, Balion and Sabang Bao containing an area of more or less three thousand (3,000) hectares;

NOW THEREFORE, the Board, on motion of Vice-Mayor Marcelo D. Bandalan, seconded by Councilor Teotimo Ocubillo;

BE IT RESOLVED, as is hereby resolved, to respectfully convey to Congressman Domingo Veloso, Speaker Protempore, House of the Representatives, Manila, the request of the landowners and tenants of barrios San Jose, Balion and Sabang Bao, Ormoc City headed by Dr. H. I. Serafica to set aside P30,000.00 out of his pork barrel fund for the construction of irrigation system utilizing the Bao River to irrigate the rice fields of aforementioned barrios;

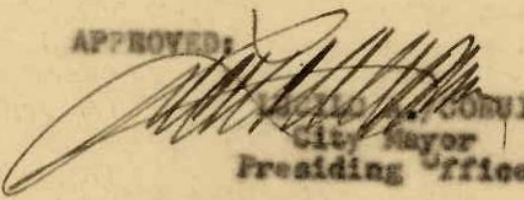
