RESOLUTION NO. 178

Letter of Hon. Juan C. Pajo, Governor, Province of
Bhhol, dated October 31, 1952, hereunder quoted verbatim
as follows:

Republic of the Philippines
Province of Bohol
Tagbilaran

Office of the Governor

October 31, 1952

My dear Mayor Conui:

The Members of the Provincial Board and Members of
the Mayors' League of Bohol, and the provincial officials
of this province, in a joint conference, unanimously
agree to meet the Members of the Provincial Board, Mayors
and other officials of that province in the island of Gaus,
Municipality of Ubay, this province, on December 13, and
14, 1952, in conformity with our conversation on this mat-
ter in Maasin recently. Various matters that would affect
the mutual welfare of the constituents of Bohol and Leyte,
like control of illegal fishing and interisland trade, and
other matters that would bring closer relationship between
the two neighboring provinces will be discussed during the
conference. An extemporaneous program, including athletics,
will be held.

Should the said dates be agreeable, your party will
be expected in Gaus at lunchtime on December 13.

BE IT RESOLVED FURTHERMORE, that the amount of P300.00 as above appropriated be taken from the per diems savings of the Municipal Board;

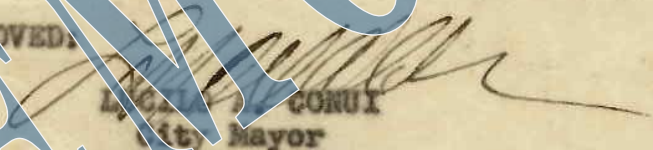
