RESOLUTION NO. 179

Letter of the City Engineer, Ormoc City, dated Nov.
14, 1952, hereunder quoted verbatim as follows:

Gentlemen:

I have the honor to request that Honorable Body to appropriate the amount of P600.00 from the Waterworks Fund as additional sum to cover costs of expenses for labor and materials for the emergency repair works of the collecting pipe line from intake No. 6 to intake No. 1.

Please be informed that further abandonment of such repair work would mean more loss of several thousand pesos, inasmuch as major damages would follow. Floods are continuously occurring, thereby scouring different sections of the pipe line and endangering breakage or cracks due to falling rocks during landslides, and other external forces that might damage the lines.

It is therefore urgently requested that immediate appropriation of the said amount be set aside by that Honorable Body.




