RESOLUTION NO. 100

WHEREAS, be it known that one, Ruperta Lacno, a resident of Ormoc City, requested the City Engineer, Ormoc City to allow her to construct a semi-permanent building for industrial purpose at San Agustin Street of Ormoc City;

WHEREAS, the City Engineer in his 1st indorsement dated November 13, 1952 expressed that he strongly objects to allow the setting up of a corn mill in San Agustin Street for the reason that the site where the building will be constructed is near the Central School and the Training Department of the Western Leyte College;

WHEREAS, Councilor Alvaro I. Gutierrez manifested that the request of Ruperta Lacno is in order because the noise that will be made by the corn mill cannot be heard from the two schools above mentioned;

WHEREAS, the Honorable Body unanimously agreed to recommend for approval, to the City Engineer, the request of Ruperta Lacno to construct a semi-permanent building at San Agustin Street for industrial purpose;

NOW THEREFORE, the Board, on motion of Councilor Alvaro I. Gutierrez, seconded by Councilor Jorge S. Tan;

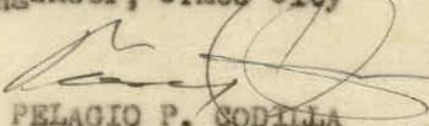
