RESOLUTION NO. 181

WHEREAS, be it known that Mr. Perfecto Bucabuca and Mr. Ricardo Rodriguez, agricultural arts and industrial arts teachers of Mas-in Elem. School and Curva Elementary School, respectively incurred actual expenses for the operation of their classes for the school year 1951-1952 in the amounts of P10.00 and P12.00, respectively;

WHEREAS, said amounts were not reimbursed by the city government of Ormoc City as the said expenses were reported after the current fiscal budget had been adopted by the Municipal Board;

WHEREAS, the City Treasurer, Ormoc City, in his 1st indorsements of the basic communications of the principal of Mas-in Elem. School and Curva Elem. School, requested the Hon. Body to authorize the City Treasurer to pay the said accounts from the current appropriation;

NOW THEREFORE, the Board, on motion of Councilor Guillermo T. Parrilla, seconded by Councilor Teotimo Ocubillo;

BE IT RESOLVED, as is hereby resolved to appropriate the amount of P22.00 to reimburse the expenses incurred by Mr. Perfecto Bucabuca and Mr. Ricardo Rodriguez in the operation of their classes during the school year 1951-1952;

BE IT FURTHER RESOLVED, that the amount as above appropriated be taken from the current appropriation of the unappropriated balance otherwise not appropriated;

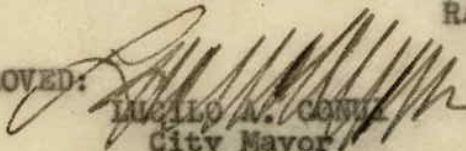

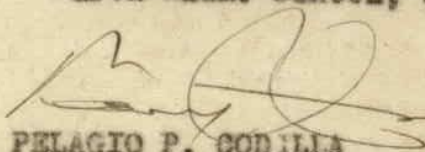
