RESOLUTION NO. 12

WHEREAS, the people of Barrio Alegria are in need of a little expansion of the school site they have newly acquired for their school children;

WHEREAS, a petition has been submitted by the residents of Barrio Alegria to Dr. and Mrs. Serafica requesting them to sell to the people of Alegria One (1) hectare of their lot to expand the said school site;

WHEREAS, this petition of the people of Barrio Alegria has been turned down by Dr. Serafica;

WHEREAS, in a petition sent to the City Council the said Barrio people of Alegria requested the City Council to expropriate the said lot of Dr. Serafica for the purpose indicated above;

WHEREAS, the Municipal Board of Ormoc City also believes that the acquisition of that lot for the purpose of expanding the school site is very essential but believed that expropriation should only be done only in extreme cases;

NOW THEREFORE, the Board, on motion of Councilor Usualdo F. Laguitan seconded by Councilor Alvaro I. Gutierrez;

BE IT RESOLVED, as it is hereby resolved, to request Dr. and Mrs. Serafica to reconsider their former decision so that for the sake of the school children of Alegria the portion of their lot requested for the expansion of school site be sold to the people of Alegria;

BE IT FURTHER RESOLVED, to appeal to Dr. and Mrs. Serafica that since the request of the people of Alegria is done not for the benefit anyone of them but the general public, that Dr. and Mrs. Serafica should kindly release a portion of their lot needed. It should be noted that the conversion of that portion of the lot of Dr. Serafica into a public plaza will render a more decent neighborhood when Dr. and Mrs. Serafica will eventually construct their residences in that place, otherwise small nipa shacks be constructed with insanitary toilets and become fire hazards will predominate that place;

RESOLVED FINALLY, to furnish copy of this resolution each to the Hon. City Mayor, Ormoc City; City Treasurer, Ormoc City; City Auditor, Ormoc City; Dr. H. Serafica, Ormoc City; the PTA Pres., Barrio Alegria, Ormoc City.

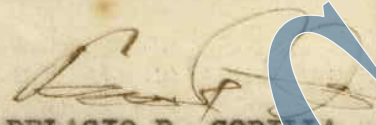
