RESOLUTION NO. 187

WHEREAS, the Chair informed the Hon. Body that the Provincial Governor of Leyte, in a letter addressed to the City Mayor, Ormoc City, stated that the share of the City of Ormoc in the construction of the Leyte Pavilion in the International World's Fair is P2,000.00;

WHEREAS, Councilor Victorino C. Teleron manifested that the City Government of Ormoc is not in a position to appropriate such amount due to the precarious condition of the city finances;

WHEREAS, Vice-Mayor Marcelo D. Bandalan suggested to the Hon. Body, that in order to raise funds for the purpose it would be necessary to request both National and City Employees in Ormoc City that they may contribute 1% of their monthly salaries and wages and the remaining balance which could not be covered by the contributions of the National and City Employees could be covered by soliciting voluntary contributions from private persons, firms and corporations;

NOW THEREFORE, the Board, on motion of Vice Mayor Marcelo D. Bandalan, seconded by Councilor Victorino C. Teleron;

BE IT RESOLVED, as is hereby resolved, to request both National and City employees in Ormoc City that they may contribute 1% of their monthly salaries and wages in order to raise funds for the share of Ormoc City in the amount of P2,000.00 for the construction of the Leyte Pavilion in the International World's Fair and to solicit voluntary contributions from private persons; firms and corporations if said amount of P2,000.00 could not be covered by the contributions of the National and City employees;

RESOLVED FINALLY, to furnish copy of this resolution each to the City Mayor, Ormoc City; City Auditor, Ormoc City; City Treasurer, Ormoc City; City Engineer, Ormoc City; City Attorney, Ormoc City; Municipal Judge, Ormoc City; Register of Deeds, Ormoc City; Chief of Police, Ormoc City; City Agronomist, Ormoc City; Fire Chief, Ormoc City; City Supervisor, District I, Ormoc City; City Supervisor, Dist. II, Ormoc City; Principal, Ormoc City High School, Ormoc City; and the Postmaster, Ormoc City.
