Body that all data regarding the proposed Reinforced Concrete Deck Girder Bridge across Panali-an River (Ormoc-Albuera National Road) had been sent to the Director of Public Works, Manila;

WHEREAS, the City Engineer further informed the Board that very recently an advance Plans of said proposed bridge has been sent to his Office for comment and further recommendations;

WHEREAS, the estimated cost for the construction of the same would amount to ONE HUNDRED FIFTY THOUSAND (P150,000.00) PESOS;

BE IT RESOLVED, as it is hereby resolved, to respectfully request the Hon. Secretary of Public Works and Communications, Manila to release the amount of ONE HUNDRED FIFTY THOUSAND (P150,000.00) PESOS for the construction of a Reinforced Concrete Deck Girder Bridge across Panali-an River the same to be taken from the revolving fund;

RESOLVED FINALLY, to furnish copy of this resolution each to the Hon. Secretary of Public Works and Communications, Manila; Director of Public Works, Manila; City Mayor, Ormoc City; City Treasurer, Ormoc City; City Auditor and the City Engineer, Ormoc City.
