(continuation from corner Rizal St.
to corner Bonifacio St.)..... P1,750.00
J-62(9) Asphaltting of Rizal St.(continua-
tion from San Jorge to Solidor
St.)..... 2,950.00

The reason is obvious, considering asphaltting to be
more of a permanent form of improvement."

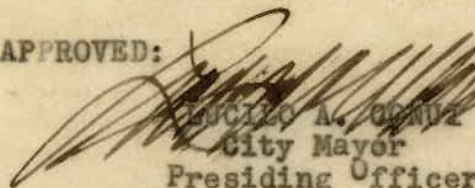
