RESOLUTION NO. 192

WHEREAS, be it known that the Municipal Board, Ormoc City passed Resolution No. 173, current series, charging 1/4 centavo for every liter of gasoline sold by gasoline dealers in the City of Ormoc;

WHEREAS, be it known further, that Ordinance No. 9, s. 1948, duly approved and enforced, has provided for a license fee of 1/4 centavo for every liter of gasoline sold by gasoline dealers in the City of Ormoc;

WHEREAS, in order to avoid repetition of the same provision above quoted the Municipal Board deems it proper to repeal the portion of Resolution No. 173, c.s., which provides for a fee of 1/4 centavo for every liter of gasoline sold by gasoline dealers in the City of Ormoc;

NOW THEREFORE, the Board, on motion of Councilor Guillermo T. Parrilla, seconded by Councilor Ifaki Larrazabal;

BE IT RESOLVED, as is hereby resolved to repeal the provision of Resolution No. 173, c.s. which provides for the charging of a fee of 1/4 centavo for every liter of gasoline sold by gasoline dealers in the City of Ormoc, the same provision being contained in Ordinance No. 9, s. 1948 of the Municipal Board, Ormoc City;

RESOLVED FINALLY, to furnish copy of this resolution each to the Hon. City Mayor, Ormoc City; City Treasurer, Ormoc City; City Auditor, Ormoc City and all operators of gasoline stations, Ormoc City.
