RESOLUTION NO. 196

WHEREAS, Resolution No. 114, s. 1952 (Appropriation Ordinance) which was vetoed by the Hon. City Mayor of Ormoc twice has been pending in the Office of the Hon. Executive Secretary of the President and in spite of representations made by the City Councilors who went to Manila for that purpose same has been pending until now;

WHEREAS, besides the above pending resolution there are other vital resolutions, the approval of which are very essential for the operation of the city government of Ormoc but which have been held pending by the Executive Secretary after the City Board has passed twice over the Mayors Veto as can be noted below wherein their passage are indicated to show how long they have been held pending by the Hon. Executive Secretary to the President, as follows:

Resolution No. 9 s. 1952- abolition of non-essential positions, dated Jan. 3, 1952.
Resolution No. 12 s. 1952- creation of a committee to find means and ways to divide Ormoc into 3 Mpl. Districts, dated Jan 5, 1952.
Resolution No. 13 s. 1952 - abolition of 6 members of the fire department and the corresponding appropriations thereof, dated Jan. 5, 1952.
Resolution No. 26 s. 1952- Repealing Res. No. 192 & 194 creating Superintendent of City Schools for Ormoc City, dated Jan. 19, 1952
Resolution No. 100 s. 1952- Creating standing committees of the Municipal Board, dated June 14, 1952

and many other resolutions;

NOW THEREFORE, the Board, on motion of Councilor Usualdo F. Laguitan, seconded by Councilor Teotimo Ocubillo;


BE IT RESOLVED, as is hereby resolved, to request His Excellency, the President of the Philippines, Manila to order the Executive Secretary to decide once and for all immediately all the above pending resolutions and all other resolutions now pending in the Office of the Executive Secretary which up to now are not acted upon with emphasis on Resolution No. 114, Budget for the City of Ormoc;

RESOLVED FINALLY, to furnish copy of this Resolution each to His Excellency, the President of the Philippines, Malacañan Palace, Manila; the Hon. City Mayor, City Treasurer, City Auditor, Ormoc City.


