RESOLUTION NO. 127

Letter of the Hon. Secretary, Department of Health,
Manila, dated November 21, 1952, addressed to the Hon.
City Mayor, Ormoc City, hereunder quoted verbatim as fol-
lows:

His Honor,
The City Mayor

Sir:

In view of the reported prevalence of influenza in
certain provinces and chartered cities, wherein all possible
health and sanitary measures are being instituted by the
Bureau of Health and its health agencies in the field to
forestall the spread of the disease, your valuable coopera-
tion in this matter is earnestly solicited. One way of ef-
fectively controlling the disease is the enforcement of the
existing ordinance in the city, if any, barring the admis-
sion to moviehouses and similar recreational centers of
children below 12 years and providing only for a maximum
number of admission in them in order to avoid congestion
or overcrowding. In the absence of such ordinance, it is
suggested that one be adopted as early as possible to eli-
minate one of the causes of the existence of the disease
in any locality. It is needless to state that with your
unstinted cooperation in this matter, the health of the
people in the community will be properly safeguarded,
thereby minimizing, if not totally preventing, the inci-
dence from such disease.
