RESOLUTION NO. 1

WHEREAS, be it known that Engr. Reroma, contractor for the construction of the city hall building of Ormoc City has presented a claim for extra payment in the amount of P4,241.15 for the concrete piers of the said building;

WHEREAS, be it known further, that the Municipal Board, in its regular session held on September 20, 1952, passed resolution No. 140, approving the claim of Engr. Reroma, the same to be carried as outstanding obligation in the fiscal year 1953-1954;

WHEREAS, on the 30th day of September, 1952, the Hon. City Mayor, Ormoc City, vetoed the said resolution No. 140 for reasons stated in the veto;

WHEREAS, Engr. Felix C. Codilla, being present during the deliberation, and who has full knowledge of the facts surrounding the claim for extra payment of Engr. Reroma, he being the incumbent City Engineer of Ormoc City during the construction of the City Hall building informed the Hon. Body that there was really an extra work done by the contractor due to the transfer of the proposed site and the City Government of Ormoc having been benefited by said extra work is duty bound to pay the same;

NOW THEREFORE, the Board, on motion of Councilor Victorino C. Teleron, seconded by Vice-Mayor Marcelo D. Bandalan;

BE IT RESOLVED, as is hereby resolved, to override the veto of the Hon. Vice-Mayor and Acting City Mayor Marcelo D. Bandalan of Resolution No. 140, s. 1952;

RESOLVED FURTHER, to furnish copy of this resolution each to the Hon. City Mayor, Ormoc City; City Treasurer, City Auditor, and the City Engineer, Ormoc City.
CARRIED UNANIMOUSLY.


