RESOLUTION NO. 4

WHEREAS, on August 23, 1952, the Secretary to the Municipal Board, by authority of the Board, sent a telegram to the Director of Public Schools requesting authority to open the 4th year class at Ormoc City High School and on July 10, 1952 the Municipal Board, thru the Hon. Vice Mayor sent another telegram requesting authority to open the 4th year class, stating that funds were available for the purpose;

WHEREAS, on Sept. 23, 1952, the Director of Public Schools, sent to the Hon. City Mayor, Ormoc City a communication approving the opening of the 4th year class at Ormoc City High School, as approved by the Div. Supt. of Schools, Tacleban, Leyte;

WHEREAS, up to the present, the three (3) teachers of the 4th year class of Ormoc City High School have not receive their salaries since assumption of service;

WHEREAS, Councilor Victorino C. Teleron suggested to the Hon. Body to approve the request of Mr. Carlos Petilla, Principal of Ormoc City High School, for a supplemental budget for the 4th year class, in his letter dated November 5, 1952 for the amount of P4,770.00 and the matter be referred to the Office of the City Treasurer for his guidance; that the funds be taken from the unappropriated balance not otherwise appropriated;

NOW THEREFORE, the Board, on motion of Councilor Victorino C. Teleron, seconded by Councilor Guillermo T. Parrilla;

BE IT RESOLVED, as is hereby resolved to approve the request of Mr. Carlos Petilla for a supplemental budget for the amount of P4,770.00 for the 4th year class of Ormoc City High School;

BE IT RESOLVED FURTHER, that appropriate the amount of P4,770.00 for the supplemental budget of the 4th year class of Ormoc City High School; the same to be taken from the unappropriated balance otherwise not appropriated;

BE IT RESOLVED FINALLY to furnish copy of this resolution each to the Hon. City Mayor, Ormoc City; City Treasurer, Ormoc City; City Auditor, and the Principal, Ormoc City High School, Ormoc City.

CARRIED. 6 votes in favor - 2 votes against.
