The undersigned therefore request that an appropriation of P5.00 be provided for by that Hon. Body in order that the 52 barrio lieutenants could be insured in accordance with the request of the Capital Insurance & Surety Co., Inc. and concurred in by the City Treasurer.

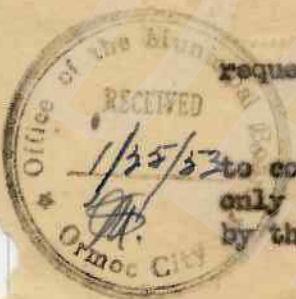
