RESOLUTION NO. 6

Letter of the Acting Chief of Police, Ormoc City
dated January 22, 1953 hereunder quoted verbatim as
follows:

REPUBLIC OF THE PHILIPPINES

22 January 1953

The Hon. Municipal Board
Through His Honor, the City Mayor
Ormoc City

S i r :

I have the honor to inform the Hon. Municipal Board
of this City that for about four (4) years the City
Government has been renting a building in Can-adieng which
is used as a City Jail at P25.00 a month.

The Building rented is an old building which is
about 500 yards from the Police Headquarters. The build-
ing is so old that it is no longer safe for dangerous
criminals. In addition, the condition is very unhealth-
ful and inadequate, besides the inconveniences it gives
owing to its distance.

Taking into consideration the above facts, this
office recommends that instead of constructing a separate
building for a City Jail, the quonset Hut now occupied
by the Police Department be reconstructed. The Office
of the City Assessor may be transferred to any place.
Only one third of the whole building which is adjacent
to the Police Department is enough for the City Jail.
The estimated amount needed to reconstruct this portion
including an additional construction of a flush toilet
is about P1,200.00. This includes materials and labor.

It is, therefore, requested that the Hon. Municipal
Board should appropriate the amount of P1,200.00 for the
reconstruction requested for.


