the honor to inform the Mon. Municipal Board of this Ity that for about four (4) years the City overnment has been renting a building in Can-adieng which sed as a City Jail at 225.00 a month.

The Ballding rented is an old building which is about 500 yards from the Police Headquarters. The building is so old that it is no longer safe for dangeours Timinals. In addition, the condition is very unhealthowing to its distance.

Taking into consideration the above facts, this office recommends that instead of constructing a separate building for a City Jail, the quonset Hut now occupied by the rolice Department be reconstructed. The Office of the City Assessor may be transferred to any place. Only one third of the whole building which is adjacent to the Police Department is enoughf for the City Hail. The estimated amount needed to reconstruct that portion including an additional construction of a flash toilet is about Pl,200.00. This includes materials and labor.

It is, therefore, requested that the Non. Municipal Board should appropriate the amount of P1,200.00 for the reconstruction requested for.
