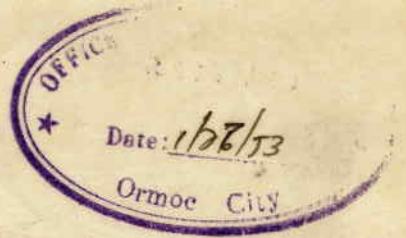

RESOLVED FURTHERMORE, that the sum of P285.00 as above appropriated be taken from the unappropriated balance not otherwise appropriated;


