RESOLUTION NO. 10

WHEREAS, be it known that the Ormoc Electric Light Company, Ormoc City, thru its Manager, Mr. C. Ratcliffe, demanded for payment of the unpaid accounts of the Ormoc Elementary School for currents used for the year 1951-1952 in the amount of P132.22;

WHEREAS, said accounts are to be paid from appropriations for the Ormoc Elementary School out of the City Funds of Ormoc City;

WHEREAS, Councilor Guillermo T. Parrilla suggested to the Hon. Body that said account be paid from the current appropriations of the Ormoc Elementary School provided payment will be recommended by the District Supervisor;

BE IT RESOLVED, as is hereby resolved to appropriate the amount of P132.22 to pay the account of the Ormoc Elementary School, Ormoc City, for light furnished by the Ormoc Electric Light Company for the fiscal year 1951-1952;

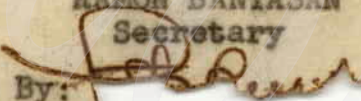

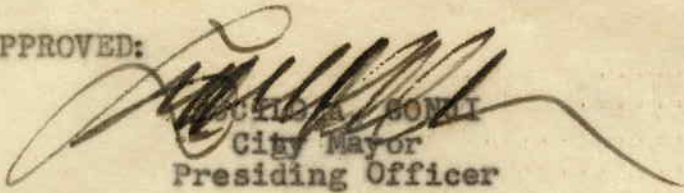
