RESOLUTION NO. 1A

WHEREAS, Councilor Alvaro I. Gutierrez brought to the attention of the Honorable Body the necessity of creating a position of a dental surgeon in the City of Ormoc to perform dental services for the inhabitants;

WHEREAS, Ormoc City with a population of more than 70,000 inhabitants do not enjoy government dental services;

WHEREAS, the City Health Officer, Ormoc City, in his letter dated February 17, 1953 addressed to the Hon. Body thru His Honor, the City Mayor, Ormoc City, strongly recommended for the creation of the position of said dental surgeon for the reason that those affected with dental troubles majority of which are indigent people cannot afford to go to private practitioners which resorted to quackery treatments;

WHEREAS, the City Health Officer further informed the Hon. Body that many dental patients went to his office for treatment but had been refused on account of lack of dental treatment facilities;

NOW THEREFORE, the Board, on motion of Councilor Alvaro I. Gutierrez, seconded by Councilor Teotimo Ocubillo;

BE IT RESOLVED, as is hereby resolved to create a position of one Dental Surgeon in the City of Ormoc to be house in the Ormoc Puericulture Center and Maternity House;

RESOLVED FURTHER, to appropriate the sum of P640.00 to cover the salary of the Dentist at P160.00 per month effective March 1, 1953 up to June 30, 1953;

RESOLVED FURTHER that the sum of P640.00 be taken from the share of Ormoc City from the Philippine Charity Sweepstakes;

RESOLVED FINALLY to furnish copy of this resolution each to the Hon. Secretary of Health, Manila; Director of Health, Manila; the Hon. Secretary of Finance, Manila; the Hon. City Mayor; City Treasurer; City Auditor; City Health Officer, all of Ormoc City.


