RESOLUTION NO. 19

WHEREAS, be it known that the Municipal Board of Ormoc City was furnished a copy of resolution numbered 18 of the Provincial Board of Leyte, passed on January 9, 1953, concurring in and endorsing Resolution No. 411, series of 1952, of the Provincial Board of Agusan, advocating the calling of convention in the City of Manila of all members of the Provincial Boards, to discuss measures which may be recommended for congressional and especially the amendment of the Autonomy Law which application does not give actual autonomy to local governments;

WHEREAS, Councilor Alvaro I. Gutierrez strongly suggested to respectfully request His Excellency, the President of the Philippines that members of Municipal Boards and City Councils of all chartered cities be authorized to attend the convention together with the members of the Provincial Boards;

WHEREAS, the Councilor further suggested that the convention be held at anytime between April 12 to 18, 1953 and to request further His Excellency, the President of the Philippines a reply of the same so appropriations could be set aside for the purpose;

NOW THEREFORE, the Board, on motion of Councilor Alvaro I. Gutierrez, seconded by Councilor Guillermo T. Parrilla;

BE IT RESOLVED, as is hereby resolved, to recommend to His Excellency, the President of the Philippines that members of Municipal Boards and City Councils of all chartered cities be authorized to attend the convention together with the members of the Provincial Boards;

RESOLVED FURTHER, to request that the convention be held between April 12 to 18, 1953 and to request further His Excellency, the President of the Philippines a reply of the same so that appropriations could be set aside for the purpose;
