RESOLUTION NO. 22

Dear Fellow Engineer:

Our House of Representatives Bill No. 2064, entitled
"AN ACT CLASSIFYING CHARTERED CITIES, EXCEPT MANILA, BAGUIO
AND QUEZON CITY, ACCORDING TO THEIR ANNUAL REVENUES AND
FIXING THE SALARIES OF THE OFFICIALS THEREOF", had been
finally and completely approved by the House of Represen-
tatives and the Senate of the Philippines. The bill (copy
of schedule of salaries is herewith attached) goes to His
Excellency, the President of the Philippines, for considera-
tion.

Let us request His Excellency, the President, to ap-
prove this bill; and I feel it is necessary that we go in
delegation with your mayor and other city officials to
petition him.

Congressmen and Senators are willing to lead and accompany
us.
