RESOLUTION NO. 28

WHEREAS, Councilor Guillermo T. Parrilla informed the Honorable Body that the dental clinic of Ormoc City ran short of medicine because of so many patients that had been treated;

WHEREAS, Councilor Guillermo T. Parrilla further informed the Honorable Body that the City Treasurer has already received the share of Ormoc City in the December 21, 1952 sweepstakes draw in the amount of P402.98, covered by Check No. M-10727 and suggested that P200.00 be appropriated for the purchase of the necessary medicine for the dental clinic of the City of Ormoc and that the remaining P202.98 be appropriated for the painting of the interior part of the Ormoc Puericulture Center and Maternity House;

NOW THEREFORE, the Board, on motion of Councilor Guillermo T. Parrilla, seconded by Councilor Teotimo Ocubillo;

BE IT RESOLVED, as is hereby resolved, to appropriate the amount of P200.00 for the purchase of medicine for the dental clinic of Ormoc City and P202.98 for the painting of the interior part of the Ormoc Puericulture Center and Maternity House; the amounts as appropriated be taken from the share of Ormoc City in the December 21, 1952 sweepstakes draw in the amount of P402.98 covered by Check No. M-10727;

RESOLVED FINALLY, to furnish copy of this resolution each to the Hon. City Mayor, Ormoc City; City Treasurer; City Auditor; City Health Officer and the City Dentist, all of Ormoc City.
