Gentlemen:

Pursuant to the provisions of Republic Act No.
837, copy attached, I have the honor to request for
the adjustment of the salary of the City Auditor
and the Assistant City Auditor, the increase to
take effect March 25 and March 20, 1953, respective-
ly, as follows:

1 City Auditor from P3240.00 to P3600.00	
per annum - - - - -	P 96.77
1 Assistant City Auditor from P1,920.00	
to P2,400 per annum - - - - -	<u>135.45</u>
Total - - - - -	<u>P 232.22</u>

It can thus be seen that the amount herein re-
quested can easily be covered by the savings from
the salary of the City Auditor which was vacant from
January 1 to March 24, 1953. In this connection, it
is requested that the amount of P232.22 be appropriat-
ed either from salary savings or from any amount not
otherwise appropriated.




