RESOLUTION NO. 33

WHEREAS, Councilor Usualdo F. Laguitan brought to the attention of the Hon. Members of the Board that during the meeting held at Barrio Ipil, Ormoc City which was attended by barrio lieutenants, Hon. Speaker Protempore Domingo Veloso promised to give aid to the City Government of Ormoc for the construction of a building for the Ormoc City High School;

WHEREAS, the Councilor further suggested to the Hon. Members of the Board to respectfully request Hon. Speaker Protempore Domingo Veloso, House of Representatives, Manila, to give to the City Government of Ormoc the amount of P20,000.00 for the construction of a building for the Ormoc City High School, the same to be taken from his pork barrel;

NOW THEREFORE, the Board, on motion of Councilor Usualdo F. Laguitan, seconded by Councilor Ikaki Larrazabal;

BE IT RESOLVED, as is hereby resolved, to respectfully request Hon. Speaker Protempore, Domingo Veloso, House of Representatives, Manila, to give to the City Government of Ormoc the amount of P20,000.00 for the construction of a building for the Ormoc City High School - as promised by him during the meeting held at Ipil, Ormoc City - the same to be taken from his pork barrel fund;


FINALLY RESOLVED, to furnish copy of this resolution each to Hon. Speaker Protempore Domingo Veloso, House of Representatives, Manila; the Hon. City Mayor, Ormoc City; City Treasurer, Ormoc City; City Auditor, Ormoc City and the Principal, Ormoc City High School, Ormoc City.


