RESOLUTION NO. 39

WHEREAS, Councilor Victorino C. Teleron informed the Honorable Body that the salaries of Intermediate Teachers in the Municipalities are not paid from the Provincial Government but from the National fund;

WHEREAS, be it known that Chartered Cities have the same category as that of a province in so far as salaries of intermediate teachers are concerned;

WHEREAS, the City Government of Ormoc can not afford to pay the salaries of intermediate teachers in view of its precarious financial condition;

WHEREAS, Councilor Victorino C. Teleron strongly suggested to request the authorities concerned in Manila that the salaries of intermediate teachers of Ormoc City be borne by the National Government in order that the amount to be allocated for the salaries of the intermediate teachers could be utilized in the re-adjustment of salaries for the City Officials and Employees as provided for by Republic Act No. 840 and the implementation of the Minimum Wage Law of the City employees;

NOW THEREFORE, the Board, on motion of Councilor Victorino C. Teleron, seconded by Councilor Usualdo F. Laguitan;

BE IT RESOLVED, as it is hereby resolved, to respectfully request the authorities concerned in Manila that the salaries of intermediate teachers in the City of Ormoc be borne by the National Government in view of the precarious financial condition of the City Government of Ormoc;

RESOLVED FINALLY, to furnish copy of this resolution each to the Hon. Secretary of Education, Manila; Hon. Director of Public Schools, Manila; Hon. Secretary of Finance, Manila; City Mayor, City Treasurer, and the City Auditor all of Ormoc City and all Chartered Cities.
