Sirs:

I am enclosing herewith a copy of Circular
No. 111, which is self-explanatory, announcing
the advice of the Manager of the UNICEF CHILD
FEEDING PROGRAM, giving this center at least 25
beneficiaries who are entitled to an allocation of 1,000
pounds of skimmed milk, upon payment of the hand-
ling expenses at the rate of P0.04 per pound from
Manila to the nearest port of call, and the "add-
itional expenses from the nearest port of call
to the Puericulture Center".

Much as I want to participate in this UNICEF
CHILD FEEDING PROGRAM, it is regretted to state that this
amount is not now covered by any item of our budget
for this year.

In this connection, it is requested that
Ormoc City, participate in this Program for at least
25 beneficiaries, and that the amount of P40.00
be given as additional aid to the Center to cover
the handling expenses from Manila, for 1,000 pounds
of skimmed milk.
