I a enclosing herewith a copy of Carcular No. 11, which is self-explanatory, announcing he dvice of the Manager of the UNICEF CHILD EEDING PROGRAM, giving this center at least 25 beneficiaries who are entitled to an allocation of 1,000 pounds of skimed milk, upon payment of the hand-ling expenses at the rate of PO.04 per pound from Manila to the nearest port of call, and the "additional expenses from the nearest port of call to the Puericulture Center".

Much as I want to participate in this UNICEF CHILD FEEDING PROGRAM, it is regreted to state that this amount is not now covered by any item of our budget for this year.

In this connection, it is requested that 6rmoc City, participate in this Program for at least 25 beneficiaries, and that the amount of \$40.00 be given as additional aid to the Center to cover the handling expenses from Manila, for 1,000 pounds of skimed milk.
