When the undersigned assumed position as Municipal
Judge last May 14, 1953, it was found out that the office
of the Municipal Judge is sadly lacking the necessary of-
fice equipments needed in the daily routine of the office.

The City Treasurer advised this office that no requi-
sition could be acted upon inasmuch as we do not have any
appropriation for the purchase of the things needed.

In view of the necessity of the equipments and
in the interest of public service and efficiency, the
undersigned respectfully and urgently requests the Hon.
the City Council, to appropriate the sum of TWO HUNDRED
(P200.00) PESOS, for the purchase of the following:

One (1) new Seal of Court
Two (2) Notarial Books
500 Notarial loose leafs
One (1) stapler

of said Office.




