RESOLUTION NO. 51

WHEREAS, the Presiding Officer, Hon. Inaki Larrazabal informed the Hon. Body that when he assume Office as City Mayor of Ormoc City effective June 3, 1953, the Secretary, Clerk Typist, Janitor and Driver of the City Mayor and two policemen, Sgt. Cresencio Agcang and Pst. Ruperto Subiron tendered their resignation effective June 5, 1953;

WHEREAS, said employees have collected their accumulated vacation and sick leave up to June 30, 1953;

WHEREAS, in order not to hamper the operation of the Office of the City Mayor and the Police Department, the Presiding Officer requested the Hon. Body to appropriate the amount of P900.00 to cover up the salary of the City Mayor from June 3 to June 30, 1953 and the salaries of the Secretary to the City Mayor, Clerk Typist, Janitor, Driver and two policemen from June 5 to June 30, 1953;

NOW THEREFORE, the Board, on motion of Councilor Alvarez I. Gutierrez seconded by Councilor Esteban C. Conejes;


BE IT RESOLVED, as it is hereby resolved, to appropriate the amount of P900.00 to pay for the salaries of the City Mayor from June 3 to June 30, 1953, Secretary to the City Mayor, Clerk Typist, Janitor, Driver and two Policemen from June 5 to June 30, 1953.

RESOLVED FURTHER, that the sum of P900.00 as above appropriated be taken from the salary savings of the Police Department.

RESOLVED FINALLY, to furnish copy of this resolution each to the City Mayor, City Treasurer, City Auditor and the Chief of Police, all of Ormoc City.
