RESOLUTION NO. 22

tration to terminate the services of the members of
the Police Department and some employees of the dif-
ferent departments whose the City Mayor has no confidence
and whose services are inefficient;

WHEREAS, according to the records of the City
Auditor's Office, there are employees whose appoint-
ments have not been duly attested by the Bureau of
Civil Service and whose appointments have not been
renewed, the same to be the first ones to be laid
off;

NOW THEREFORE, the Board on motion of Councilor
Victorine C. Teleron seconded by Councilor Teetime
Ocubille;

BE IT RESOLVED, as it is hereby resolved to
respectfully request the City Treasurer and the City
Auditor to submit to the Municipal Board the estimate
of the total obligation of the city government in the
form of terminal, vacation and sick leave of the
employees whose services are to be terminated in
accordance with the recommendation of the City Mayor
in order that said amount could be carried as out-
standing obligation for the next budget for the fiscal
year 1953-1954.

RESOLVED FINALLY, to furnish copy of this re-
solution each to the City Mayor, City Treasurer and
the City Auditor all of Ormoc City.


