I would like to inform the Honl Municipal Board of
this city, that the amount of P1,200.00 which was

jail was not sufficient.

I respectfully request, therefore, that an additional
amount of P800.00 be appropriated for the compleation
of the said construction. This will include 15 double
deck beds for the prisoners.


