RESOLUTION NO. 58

WHEREAS, be it known that the Municipal Board of Ormoc City in its special session held on August 18, 1951 passed resolution No. 114, increasing the daily subsistence of each prisoner in the city jail of Ormoc City from .60 to .80 per day;

WHEREAS, the Deputy Auditor General in his letter dated Oct. 3, 1951 offer no objection to increasing the cost of subsistence furnished to the prisoners of Ormoc City as per resolution No. 114 series of 1951.

WHEREAS, be it known that up to the present, Mrs. Eduarda Tomada (Caterer) has not yet collected the difference of P650.70 in view of the precarious financial condition of the City government of Ormoc;

NOW THEREFORE, the Board, on motion of Councilor Victorino C. Teleron, seconded by Councilor Guillermo T. Parrilla;

BE IT RESOLVED, as it is hereby resolved, to appropriate the amount of P650.70 to cover the difference of the daily subsistence of each prisoner of Ormoc City from .60 to .80 per day;

RESOLVED FURTHER, that the amount of P650.70 as above appropriated be taken from the discretionary fund of the City Mayor.

RESOLVED FINALLY, to furnish copy of this resolution each to the City Mayor, City Treasurer, City Auditor and to Mrs. Eduarda Tomada all of Ormoc City.
