RESOLUTION NO. 69

WHEREAS, the City of Ormoc is cognizant of the fact that during the months of May and June, 1953, illegal fishing by dynamite along the coasts of Ormoc City, Municipalities of Albuera, Marilao and Palawan is almost checked due to the untiring efforts and vigilance of the Philippine Constabulary men under the able command of Captain Manuel Donato, thru and by the use of systematic methods in apprehending dynamiters by means of modern facilities like fast outboard motors boats;

WHEREAS, the Honorable members of the Board believed that if more facilities be extended to the Philippine Constabulary stationed in Ormoc City, to maintain these activities, our fishing industry will be encouraged to a high degree and that this particular resource of our country can be protected from that horrible destruction;

NOW THEREFORE, the Board, on motion of Vice Mayor Maximo Malinao seconded by Councilor Guillermo T. Parrilla;

BE IT RESOLVED, as is hereby resolved, that we members of this Board with the complete and wholehearted acclamation of the more than 80,000 inhabitants of this city commend the efforts of the Constabulary men presently stationed at Camp Downes, 3rd Leyte P.C. Co., in Ormoc City, this province, requesting that this noble efforts and services will continue until the elimination of illegal fishing by dynamite is completed and the apprehension of the culprits;

RESOLVED FURTHER, that this city and neighboring municipalities pledge its support both material and moral in the laws and activities of this Constabulary units in the complete elimination of illegal fishing in this municipality, if given a chance this 3rd Leyte P.C. Co. under the able command of Captain Manuel Donato, there is still plenty of room for improvements and their works will be efficient;

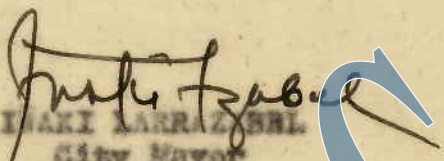
